

### REQUEST FOR BIDS FOR THE CONSTRUCTION OF FIVE (5) IRRIGATION SYSTEMS IN THE UPPER WEST REGION OF GHANA

#### 1.0. BACKGROUND

ActionAid Ghana (AAG) is a non-governmental organization registered in Ghana as a National NGO and has been working in the country since 1990. AAG is a member of the ActionAid International Federation, dedicated to social justice, poverty reduction, and human rights. AAG's strategic interventions focus on gender equality, youth empowerment, climate resilience, and addressing inequalities in marginalized communities. As part of the implementation of the EU-funded **"Resilience Against Climate Change"** Project, AAG is implementing the **"Strengthening Community Resilience Through Community Action Plans (CAPs)"** in the Upper West and Savannah regions of Ghana. This project seeks to improve access to water resources and irrigation infrastructure, as well as enhance afforestation and soil health in targeted communities. To support the successful delivery of this project, AAG is inviting **qualified construction firms** to bid for the Construction and Rehabilitation of **5 irrigation facilities** in **5 districts** across some selected communities within the target regions.

The irrigation facilities will support local farmers, strengthen food security, and contribute to sustainable livelihoods in the region.

### 2.0. SCOPE OF WORK

The selected contractors will be responsible for:

- Conducting site assessments and validating the feasibility studies.
- Validating technical designs and specifications.
- Constructing, rehabilitation and installing irrigation infrastructure, including canals, and distribution systems.
- Ensuring environmental, safety, and quality standards are met.
- Engaging and training local communities on the use and maintenance of the facilities.

- 4. **Company Profile** Including registration details, relevant experience, and technical team by filling the Tender forms attached
- 5. **References and Past Projects** At least two references and evidence of similar past projects.
